The other day I read an interesting short article whose premise is that we need to be more like spiders. Yes, you read that correctly—spiders. First, spiders build their lives on thin filaments strung out across one or more items. When the wind blows, the web will move violently but the spider remains calm in the web. They do the same during heavy rainstorms. Second, spiders are very patient. They wait for their food to get caught in their web. There is nothing a spider can do but wait for their daily food to arrive. Lastly spiders thrive no matter how they get to some place, and they flourish there.

Psalm 46:10 says, "Be still and flourish no matter the know that I am God" I will be exalted among the nations, I will be exalted over the earth." The word "still" in Hebrew means to stop or to surrender. Maybe we could

read verse 10 as, "Surrender and know that I am God". Surrender is not a word we generally like. We like to believe that if we fight on, we will win. When life hits us hard, we have the strength to get through it. However, we are called to surrender, to give up, to stop fighting. This verse is telling us to surrender and let God take control. Like the spider, we can do nothing about the storms in our lives except to hold on and ride the storm out. Like the spider too, we wait for our daily bread. In his Small Catechism, Martin Luther said daily bread is "everything included in the necessities and nourishment for our bodies "

Do we thrive and conditions? God places everyone to carry out His mission to the world.

Good Shepherd Lutheran Church Council met on August 8th after the worship service. Those in attendance were: Chris Johnson; Johannah Pollert, Larry Hill, Rose Krimmel, Don Haddock, Kevin Weber, Heidi Baca, Michelle Walker, Gerda Martin, Pastor and Randy Powers. Those absent were: Dan Bonham and Mark Ploss.

The minutes were reviewed and approved with a correction.

Rose Krimmel, Financial Secretary, reported the June offerings were \$18,246.31 and July's were \$14,884.45 (this includes a transfer from savings of \$1,000.00).

Larry Hill, Treasurer, reported expenses for June were \$19,462.43 and July's expenses were \$15,275.88.

Pastor Daene reported he had 7 worship services; 5 member visits; 9 in-home communion visits; and 15 Bible studies.

He will start Confirmation Class on Wednesday, September 8 at 5:30 p.m.

Kevin Weber, Deacon Chairman, stated that a single deacon will be helping with communion and an usher will be releasing the members to the altar beginning immediately.

Don Haddock, Trustee Chairman, reported water testing is up to date. The A/C units were repaired. The mowing is going well. A new mower was donated to the church. Trimming of the pines is being done. The wood sign at the end of the driveway has been repaired and repainted. It will need to be replaced in a couple of year's.

Heidi Baca, Christiaan Education Chai, reported during the Summer Johannah Pollert taught a series on Christian Values to the Sunday School class. The VBS theme was "Go Tell it on a Mountain" in June. They had a wonderful group of children. Fall Sunday School started on Au-

gust 22.

Michele Walker, Mission Chairman, stated we had 78 pounds of toilet paper, dish soap, and laundry detergent to donate to Interchurch Food Pantry in July.

Gerda Martin, Fellowship Chair-Special Events reported we had Ben Daene's Gradustion Reception and Father's Day Treats in June. Then in July we had a combo Baby Shower for Connie Daene Moore and Pitch-In.

Think about serving on Church Council 2022-2023 ~~ The positions and duties are listed below for election in December:

President —

The President shall:

- In association with the Pastor be the executive director of the total congregational program;
- 2. Prepare the agenda, according to Article I of the bylaws, and preside over all meetings of the Church Council and the Voter's Assembly;
- 3. Confer with the Pastor and the Vice President on all matters relating to the spiritual and material welfare of the congregation and its members;
- 4. Be an ex-officio member of all boards and committees, and attend or designate the Vice President to represent him at the meetings of the boards and committees as he deems necessary or advisable;
- Make an annual report of his administration to the Voter's Assembly.

Recording Secretary —

The Recording Secretary shall:

- 1. Be the official depository of the official records of the Voter's Assembly and of the Church Council;
- Record the minutes of the Voter's Assembly and of the Church Council:
- 3. Maintain a separate Constitution Book for the Signatures

of voting members;

- 4. Record attendance at Voter's Assembly and at meetings of the Church Council;
- 5. Keep an up-to-date listing of voting members;
- 6. Serve as the Historian for the congregation.

Treasurer —

The Treasurer shall:

- Be responsible for the safety of the funds of the congregation;
- 2. Keep the funds of the congregation on deposit in a bank or other reliable financial institution;
- 3. Keep the financial records of the congregation according to proper accounting procedures;
- 4. Make regular financial reports to the Church Council and to the congregation;
- 5. Be concerned with the safe deposit and recording of all funds, monthly remissions of offerings for missions and church agencies, and prompt payment of all bills and salaries as authorized by the congregation and its Boards;
- 6. Submit records to an annual audit:
- 7. Serve as a member of the Board of Stewardship.

Continued below —

Board of Stewardship —

Shall consist of five or more members, i.e., the elected Chairman of the Board, the Financial Secretary, the Treasurer, and additional members of the Congregation.

They shall:

- 1. Discover the talents of the membership and enlist them in the congregation's programs;
- Sponsor stewardship and mission talks, discussions, conferences, etc. in the congregation and in all of its organization;
- 3. Work in close cooperation with the Circuit and District Stewardship entities;
- 4. Instruct the people in the grace of proportionate giving to God's work in their own parish and in the world;
- 5. Supervise the raising of all funds in the congregation;
- 6. Keep the Pastor, the Church Council, and all Boards informed as to the financial standing of the church to ensure efficient expenditure of all funds on hand and;
- 7. Prepare the annual proposed budget for submission to the December Voter's Assembly.

- 2. Recommend regulations governing the use of the church's property;
- 3. Issue and recall keys for the church's property, keeping a list of such keys and annually reviewing such list;
- 4. Plan, enlist and supervise crews for special repairs, property improvements, etc. as the need arises;
- Draw up contracts, accept and receive grants and bequests, and all other business of the congregation as assigned to them by the Voter's Assembly;
- 6. Maintain an up-to-date inventory of all the church's equipment and property;
- 7. Submit annually to the Church Council an insurance program to properly protect the congregation;
- 8. Develop all policies and fees for rental, use and lending of the church's properties;
- 9. Submit an annual budget to the Board of Stewardship as requested by the Board.

Member-at-Large — ONE

They shall:

- 1. Attend Church Council meetings;
- 2. Council will direct on miscellaneous items brought before the Council.

Board of Trustees —

Shall consist of the Chairman and three (or more) members. They shall:

Inspect and supervise maintenance of all the church's properties and make recommendations accordingly;
